PRESS RELEASE DEATH OF A REMAND PRISONER NO. NYA: 211/2025 LAZARUS KAHANGIRE OF NYABUHIKYE GOVERNMENT PRISON

The late remand prisoner, No. NYA: 211/2025, Lazarus Kahangire, a male adult aged 48 years, was admitted to UG. Prison Nyabuhikye in Ibanda District on 20/3/2025 on charges of attempted murder C/S 187 (a) of the Penal Code Act (PCA).

Right from the time of admission, he was weak, weighed 49 kg, and had a medical history. Unfortunately, after two weeks in custody, on 04/4/2025 at around 0815 hrs, he succumbed to illness at Ruhoko Hospital, and his relatives were duly informed.

The postmortem report stated the cause of death as lobar pneumonia and anaemia.

It is regrettable that the mob took the law into their own hands, attacked, and wrongfully killed Police Officer No. 75290, PC Suleiman Chemonges, who was on duty.

Uganda Prisons Service (UPS) condemns this barbaric act in the strongest terms possible. Uganda Police Force should ensure that the culprits are brought to book.

UPS continues to extend condolences to the families of the police constable and the deceased prisoner.

May the souls of the deceased rest in eternal peace.

INFRASTRUCTURAL DEVELOPMENT IN UPS: SPOTLIGHT ON UG. PRISON - NGOGWE

The Commissioner General of Prisons, Can. Dr. Johnson Byabashaija, led a strategic and policy working tour at UG. Prison Ngogwe in Buikwe District, East Central Region, where he officially opened a newly established female section. Accompanied by UPS top management, department heads from Prisons Headquarters, and Regional and District Prisons Commanders, the visit underscored the Uganda Prisons Service's (UPS) commitment to improving infrastructure, staff welfare, and inmate rehabilitation.

r. Byabashaija commended Ms. Esther Lamunu, Superintendent of Prisons and Officer-in-Charge of Ngogwe Prison, for her innovative leadership in driving infrastructural advancements, particularly the new female section designed to enhance access to justice for female inmates. He hailed Ngogwe Prison as a model facility, urging other Officers-in-Charge (OCs) across the region to replicate its achievements to elevate UPS's corporate image.

Addressing OCs and their deputies from the East Central Region, Dr. Byabashaija emphasized compliance with H.E. President Yoweri Museveni's April 29, 2022, directive mandating staff accommodation. He stressed adherence to UPS's transfer policy, proper authorization, and the pursuit of professional courses to boost capacity.

Highlighting the need to reduce prison congestion, he called for collective efforts to maintain discipline, security, integrity, and professionalism—core UPS values—both on and off duty.

In his remarks to Ngogwe Prison staff, the Commissioner General outlined policies on transfers, training, and education, encouraging regular medical checkups and healthy living. He urged staff to engage in income-generating activities to enhance welfare and expressed gratitude to President Museveni for the recent salary increment for all UPS personnel. Commending their smartness and patriotism, he encouraged them to sustain high standards of service.

Ngogwe Prison has made strides, including constructing new prisoner wards to alleviate congestion, building staff houses to improve welfare, and launching a tree planting campaign to promote environmental stewardship. The Commissioner General officially launched the campaign during the visit, emphasizing the importance of sustainable practices to combat climate challenges within prison facilities. The newly opened female section at Ngogwe Prison features gender-specific wards, modern sanitation, and dedicated rehabilitation spaces tailored to female inmates' needs. Equipped with enhanced security and health amenities, the facility reduces congestion, promotes humane custody, and sets a benchmark for gender equity in Uganda's prison system, aligning with national development goals.

The opening of the female section and the tree planting initiative reflect UPS's broader mission to foster sustainable, equitable, and professional prison services, contributing to a safer and more inclusive society.

The state-of-the-art facility, equipped with advanced medical infrastructure, promises to transform healthcare for prison staff, inmates, and surrounding communities.

he hospital boasts cutting-edge features, including admission wards, an intensive care unit (ICU), maternity wards, surgical theaters, and diagnostic centers. During the inspection, Dr. Byabashaija and his team reviewed equipment demonstrations and patient care protocols, ensuring the facility meets high standards of medical excellence. Designed with a patient-centered approach, the hospital emphasizes preventive care, public health initiatives, and personalized treatment to promote overall well-being.

The Luzira Prison Staff Hospital is set to revolutionize healthcare access for UPS staff, inmates, and residents of nearby communities, including Mutungo, Luzira, Kitintale, Mbuya, Namwongo, Nakawa, Kinawataka, and Bugolobi. By providing on-site emergency care, the facility reduces the need for external referrals and eases pressure on public hospitals. Its accessible services are expected to enhance community health, address

disparities, and improve quality of life in the region.

Dr. Byabashaija hailed the hospital as a major boost to staff welfare and community well-being, aligning with UPS's strategic goals of rehabilitation, social equity, and socio-economic transformation. "This facility sets a new benchmark for prison healthcare, ensuring exceptional patient care, safety, and satisfaction," he said, underscoring its role in fostering a healthier society.

The health facility's objectives include delivering high-quality, patient-focused care, improving health outcomes, and promoting continuous improvement while reducing costs. By integrating advanced medical technology and compassionate protocols, it addresses both immediate healthcare needs and long-term public health goals.

This facility not only strengthens UPS's commitment to its workforce and inmates but also serves as a model for innovative prison healthcare, contributing to the broader vision of a healthier, more equitable Uganda.

Dr. Kisambu, Assistant Commissioner of Health Services at Prisons Headquarters, outlined the hospital's ambitious goals during the visit. "Our focus is to provide quality, specialized healthcare for our officers while extending services to the public," he said, emphasizing expansion, administrative restructuring, staff capacity building, and enhanced service delivery.

The Hospital Medical Superintendent, Dr. Richard Jingo has seen exponential growth, with over 2,200 patients seeking treatment monthly, totaling approximately 7,000 clients per quarter. Patients from Jinja, Mpigi, and other districts are drawn by the hospital's reputation for excellence and free services. "Word has spread about our quality care," Dr. lingo "Many based come noted. patients on recommendations from others who received effective treatment here."

The hospital offers a wide range of services, including maternal and child health (MCH) with free antenatal, postnatal, and delivery care; general medicine for chronic and emergency conditions; specialized surgical services, including hernia and orthopedic procedures; physiotherapy and rehabilitation; dentistry; mental health support; and infectious disease management, with dedicated units for HIV/AIDS, TB, and malaria. A standout feature is the hospital's TB program, which includes a two-week isolation period for directly observed therapy (DOTS) and specialized care for multidrug-resistant cases. Emergency and critical care services, supported by a 24-hour power backup, standby ambulances, and an intensive care unit, ensure uninterrupted operations.

Strategic partnerships with Mulago National Referral Hospital, international health agencies, and KCCA strengthens the hospital's capacity, ensuring a steady supply of medicines and ongoing staff training. However, challenges remain, including overwhelming patient numbers, staffing shortages, and insufficient infrastructure to accommodate the growing demand. Dr. Kisambu highlighted ongoing efforts to recruit more doctors, nurses, midwives, and technicians to address these gaps.

A notable concern is the low number of male patients, with Dr. Jingo observing that men often delay seeking care until critically ill. To counter this, the hospital is launching targeted health awareness campaigns to encourage men to prioritize early check-ups.

Looking ahead, UPS plans to elevate Luzira Prisons Staff Hospital to General Hospital status, with expansions to include new wards, specialized units, and improved staff accommodation. These upgrades aim to enhance diagnostic and surgical capacity to meet the needs of its growing patient base.

SUCCESSFUL INSPECTION OF THE JLOS TOWER: A HUB FOR JUSTICE REFORM

The Uganda Prisons Service (UPS) top management, led by Deputy Commissioner General of Prisons Mr. Samuel Akena, conducted an inspection of the ongoing construction of the JLOS House Tower on Plot 98-102, Katalima Road, Naguru. This state-of-the-art facility is set to revolutionize Uganda's Justice, Law, and Order Sector (JLOS) by consolidating key institutions under one roof, enhancing service delivery, accessibility, and operational efficiency.

The delegation toured sections for Prisons desianated the new Headquarters, which will house the Commissioner General of Prisons, the Deputy Commissioner General, six directorates, 20 departments, and various divisions and sections. The ILOS House Tower is designed as a one-stop service center, accommodating major institutions such as the Ministry of Justice and Constitutional Affairs, Ministry of Internal Affairs, Uganda Human Rights Commission, Uganda Prisons Service, Uganda Registration Services Bureau (URSB), Tax Appeals Tribunal (TAT), Uganda Law Commission (ULRC), Judicial Reform Service Commission (JSC), Directorate of Public Prosecutions (DPP), and the ILOS Secretariat. The facility will also include the Criminal, Anti-Corruption, International Crimes, Civil, Family, and Land Divisions of the High Court.

Ms. Rachel Odoi-Musoke, Senior Technical Advisor to the Governance and Security Programme, highlighted the tower's innovative features, including green and intelligent building designs that prioritize sustainability and efficiency. "The JLOS House addresses the challenge of scattered institutions operating in rented, inaccessible premises unfit for public service," she said. "By centralizing operations, it will streamline communication, foster collaboration, and improve access to justice, particularly for the poor and marginalized."

Conceived in 2005, the JLOS House project responds to the inefficiencies of dispersed JLOS institutions, which cost the government USD 8.5 million annually in rent for spaces lacking adequate facilities. The tower aims to eliminate these costs, provide purpose-built accommodations, and align infrastructure with modern business processes.

Additional objectives include establishing a green and intelligent police headquarters to enhance policing services and a Judiciary headquarters with Appellate Courts to improve judicial access, all supporting Uganda's vision of becoming a middle-income nation by 2040.

Funded through a Public-Private Partnership (PPP), the project is in advanced stages, with ongoing negotiations between JLOS and a preferred investor to finalize scope and financing. Upon completion, the tower will introduce modern office management, environmental conservation, and efficient resource use, setting a new standard for public sector infrastructure.

Mr. Akena expressed enthusiasm for the project's transformative potential for UPS. "This facility will create a conducive working environment for our staff and significantly enhance our ability to serve the public effectively," he said.

LECTURES OF OPPORTUNITY: THE PRISONS INTERMEDIATE COMMAND AND STAFF COURSE

NRM's Contributions To Uganda's Stability, Economic Growth, And Infrastructure Development Since 1986

Hon. Richard Todwong, Secretary General of the National Resistance Movement (NRM), delivered a compelling address at the Third Intermediate Command and Staff Course at the Prisons Academy and Training School, emphasizing the role of state institutions in Uganda's socio-economic transformation.

on. Todwong clarified the distinction between the state and government, noting that the state encompasses enduring institutions like the Uganda Prisons Service (UPS), which operate beyond the tenure of any government to ensure continuity and stability. The government, he explained, is the elected body that exercises executive power within the state framework, as outlined in Uganda's presidential republic system per the Constitution.

Highlighting the UPS's role as a state entity, Hon. Todwong emphasized its contribution to socio-economic transformation. He aligned with the UPS's mission to transform prisoners into responsible, law-abiding, and economically productive citizens,

referencing their goal from ugandaprisons.go.ug. "By rehabilitating offenders, the Prisons Service not only ensures security but also fosters economic productivity, reducing recidivism and contributing to national development," he stated.

Hon. Todwong traced Uganda's social system and historical evolution, noting the nation's journey from colonial fragmentation to post-independence challenges, as detailed in A History of Modern Uganda by Cambridge. He highlighted the cultural and intellectual revival under the NRM since the late 1980s, which has enriched Uganda's socio-economic fabric through advancements in health, gender equity, and education.



Urging a mindset shift, Hon. Todwong called on Ugandans to appreciate the nation's progress under President Yoweri Museveni's leadership. He cited the NRM's restoration of stability post-1986, ending decades of civil war, as a testament to Museveni's sacrifice for peace and prosperity. However, he acknowledged challenges, with youth unemployment at 62% as per Wikipedia's NRM entry, urging greater public engagement in socio-economic activities to address such gaps.

The NRM's contributions to socio-economic transformation were a focal point, with Hon. Todwong crediting the party for economic growth and infrastructure development since 1986. Yet, he noted criticisms of corruption, with the U.S. State Department's 2012 report estimating annual losses of 768.9 billion shillings, calling for renewed efforts to ensure transparency.

Hon. Todwong concluded by stressing the need for Ugandans to actively participate in production and socio-economic activities, aligning with the NRM's vision of economic liberalism and social conservatism to drive sustainable growth. His address resonated with the audience, reinforcing the UPS's pivotal role in Uganda's ongoing transformation.

A vision for modern and efficient service

Key initiatives include mechanized prison farms, irrigation systems, and industrial workshops for furniture, leather, and soap production.
